



**Recommendations by Veda Samskruti Samiti
to The Hindu Dharmic body meeting to be conducted by
Pujyashri Chinaa Jeeyar Swamiji on 7th and 8th Feb 2022**

1. Temples

- 1.1 Temples are to be taken out of the control of State and Central govts. Means they shall be made autonomous bodies under the control of “Hindu *Dhaarmic* body”. A new Body can be constituted for this purpose.
- 1.2 Temple donations and properties shall be utilized for the maintenance of temples, propagation of sanaatana dharma and renovation all old temples
- 1.3 *Kaashi Vishwanath* and *Madhura Srikrishna* temples *punarnirmaan* in the historic location.
- 1.4 *Srikrishna Janmasthanam* shall be opened for public *darshanam* and prayers.
- 1.5 Endowment act is to be abolished.
- 1.6 An Apex “Hindu *Dhaarmic* body” shall be formed with participation of *Adishankarapeethas* including *Kanchipeetham* and all *Vaishnava Raamaanujaacharya* and *Madhvaacharyapeethams*. This Hindu *Dhaarmic* body will act as an apex body for all issues concerning to sanaatana *dharma/Hinduism*. Formation of this apex body will unify all *bhaarateeyas* under one umbrella and act as guiding and guarding force for all Hindu community. This apex body will be at liberty to include any other dharmic body as co-member, at their choice. The main aim of this apex body is also to eliminate all misunderstandings and difference of opinions among various sections of Hindu *dhaarmic* forces and build up a unified *dhaarmic* force to act as guiding and guarding force for all Hindu community.
- 1.7 Govt and judicial systems shall not interfere in customs and practices of Temples and their management and customs of Hindu population without the consent of Hindu dharmic apex body. Any social justice matters shall be handled with the clear and written consent of Apex “Hindu *Dhaarmic* body”.
- 1.8 No political bodies should be in the management of Temples and its boards. All the employees presently working in such temple bodies shall be retained in case they adopt Hinduism and sanaatana dharma or else to be removed from the service.
- 1.9 All past accounts and funds and properties of temples are to be handed over to Dharmic body and the respective temple managements under the supervision of “Hindu *Dhaarmic* body”.
- 1.10 “Hindu *Dhaarmic* body” will work as apex body and the individual temples will have Representatives of each *Dharmakartamandali*. The *DharmakartaMandali* will work under the apex “Hindu *Dhaarmic* body”.
- 1.11 The Donors and the local dharmic gurus shall be given due position by rotation in the *Dharmakartamandali* of the temples and shall be approved by the *Apex Dhaarmic Body*.

1.12 Govt rules, Taxes and accounting shall be same for all *dhaarmic*/religious institutions of the country. (Present system is worse than *gigia* tax as adopted during Moghul rule). Temple funds shall not be taken by any Government.

2. Laws with Religious Bias:

In the light of History of Various countries in the past 1500 years, conversions area matter of great concern to Hindus and thereby Existence of Sanaatana Dharma. It needs to be checked. The biased Constitutional provisions with respect to Hinduism vs Other religions under the name of minority protection is detrimental to the existence of Hindus in their own country and continuance of sanaatana dharma. The secular nature of Hindus and *sanaatadharma* such as *sarvamata samabhaavanaa* and *vasudhaiva kutumbam* is resulting death signals for the *Hindus and Sanaatana Dharma*. Hence:

2.1 Uniform Civil Code is to be implemented.

2.2 Adequate steps to be taken to eliminate all types of Islamic Jihad and terrorism.

2.3 The **Rohingyaas, Bangladeshis** and any other country influx "other than Hindus and others belonging to religious practices originated from *Hinduism and Sanatana dharma*" shall be controlled and shall be treated as non-citizens of India by cancelling all sorts of IDs obtained by them through dubious means and sent out of the country.

2.4 Political parties favoring Islamic terrorism and Christian dubious conversions shall be banned.

2.5 Foreign funding in any manner for religious promotion in the country for Islamic terrorism and dubious Christian conversions shall be banned.

2.6 All religious bodies shall be under uniform rules of Government in respect of Taxes and Accounting.

2.7 All sorts of propaganda against Hindu customs and culture should be banned and considered as interference into other religious matters and shall be punished under criminal law. "*Hindu Dharmic body*" shall be formed and any sort of media publication on Hinduism shall be approved by them.

2.8 There shall be State monitoring of education given in "*Madraasaas*".

2.9 There shall not be any '*Halaal*' labelling of Foods or any Materials.

2.10 The protection of cows shall be legalized any deviation shall be treated as criminal offence.

2.11 The Cow of Indian breed shall be declared as National Pious Domestic Animal.

2.12 Bhaarateeyaa temples protection cell shall be adopted and implemented.

3. All Adishankarapeethaas (including Kanchi) and Raamanuja, Madhva Vaishnava peethaas and shaktipeethaas shall forget their differences of opinions and stand as a unified body and guide the Hindu samaajam and shall act as independent body free from any political affiliation. Any political decisions that are implemented which harms the welfare of the Hindu samaajam such as

Madhyapaanam and Cow slaughter, aggression and destructions of temples shall be taken up by the **Apex Dharmic Body** with the concerned government agencies. For such activities Hindu Temple funds can be utilized.

4. Promotion of Nationalism and Hinduism

4.1 National heroes State-wise and on all India basis shall be reviewed and published.

5. New Education Policy

5.1 Samskritam medium primary schools, at least 1000 to begin with on 'All *Bhaarat* basis' shall be started with immediate effect.

5.2 The New Education Policy is to be implemented with immediate effect.

5.3 *Bhaarateeya* history books are to be rewritten. School Textbooks shall be revised reflecting Historical facts.

All atrocities committed in the last 1000 years to be exposed and heroes of the country shall be given due recognition.

5.4 In all public schools either run by Government or Private - there should be **Saraswatypraarthana**, **National Anthem** and **Vandemaataram**. A new and uniform *Praarthana* system on these lines all *bhaarat* basis is to be written and is to be adopted.

5.5 Skill development shall be introduced with a subject on "cottage industries" - right from middle school level.

5.6 Institutes teaching/conducting Research in the Areas of Naturopathy, Ayurveda shall be established on par with allopathic medical colleges.

5.7 *Vedicpathashaalaas* shall be established, where subjects of Samskritam, Mathematics, Science, History, Computers and English are also taught on par with other general education institutions.

5.8 All school and college books shall include Hindu *Dharmic* syllabus and books shall be written on *sanaatanadharmic* lines. In case any other religion has objection, they can admit their kids in the schools run by their religions.

5.9 No school curriculum shall teach hatred against other religions. No school management shall insist rules against the customs of Hindu culture and dress code.

5.10 Candidates having Vedic education also be considered as eligible Candidates for Union Public Service Commission examinations including Civil Services.

**6. Efforts to be undertaken for Collection, Protection and Preservation of
*Sanaatana Dharmic Manuscripts (including Vedaas).***

- 6.1 A National University shall be established as an independent autonomous body with the involvement of "Hindu Dharmic body".
- 6.2 Details of Hindu manuscripts available all over the globe shall be collected and listed out. Efforts shall be done to bring back all the original manuscripts back to the country. If Originals are not obtainable, authentic Copies shall be obtained and preserved. A Research body shall be established to conduct Research on Manuscripts.
- 6.3 Efforts shall be done to locate the Veda Shaakhaas that are said to be 1131 numbers that may be lying in International museums and Libraries of various countries. These shall be brought back to the country and taught in Veda Schools.
7. **Sharadachattam shall be amended and Nitya Agnihotra Vaidic Brahmin families shall be allowed for Child Marriages. However, these young couples will have their nuptials after attaining Marriageable Age.**

Nitya Agnihotri's are to be developed for conducting all *shrautayaagaas* as per *vedic* practices and procedures.
